

Ground Speed Warriors 2025 Ford F-150 XLT 4x4 Giveaway

Purchase Entry Rate	Five (5) entries for every whole dollar spent on eligible digital posters or merchandise through shop.groundspeedwarriors.org , excluding taxes, shipping, handling, and discounts.
Mail-In Entry Method	Accepted. Each valid, individually mailed, hand-printed mail-in entry receives one (1) Giveaway entry.
Sweepstakes Period	Begins May 20, 2026 at 12:00:01 a.m. Central Time and ends September 7, 2026 at 8:00:00 a.m. Central Time.
Mail-In Deadlines	Mail-in entries must be postmarked by August 24, 2026 and received by September 11, 2026.
Drawing Date	On or about Monday, September 14, 2026 at 12:00 p.m. Central Time.

1. Sponsor and Administrator

The Ground Speed Warriors 2025 Ford F-150 XLT 4x4 Giveaway (the "Giveaway" or "Sweepstakes") is sponsored and administered by Ground Speed Warriors, 908 N Oakley St., Luverne, MN 56156 (the "Sponsor" and "Administrator").

All decisions of Sponsor regarding eligibility, entry validation, winner selection, prize award, and interpretation of these Official Rules are final and binding.

2. Eligibility

The Giveaway is open only to legal residents of the United States who are at least eighteen (18) years of age at the time of entry and who reside in a jurisdiction where the Giveaway is not prohibited or restricted by law.

The Giveaway is void in any state, territory, jurisdiction, or location where prohibited, restricted, taxed, bonded, registered, or otherwise regulated in a manner that would make the Giveaway unlawful or impractical for Sponsor to administer.

Employees, officers, directors, representatives, agents, contractors, affiliates, advertising or promotional agencies, fulfillment partners, and immediate family or household members of Ground Speed Warriors or any entity involved in the Giveaway are not eligible to enter or win.

3. Agreement to Official Rules

By participating, each entrant agrees to be bound by these Official Rules, Sponsor's privacy policy, and Sponsor's decisions. Winning the Grand Prize is contingent upon fulfilling all requirements in these Official Rules.

4. Sweepstakes Period

The Giveaway begins at 12:00:01 a.m. Central Time ("CT") on May 20, 2026 and ends at 8:00:00 a.m. CT on September 7, 2026 (the "Sweepstakes Period"). Sponsor's database computer and/or order-management system is the official time-keeping device.

Entries submitted or received outside the applicable entry deadlines, as determined by Sponsor in its sole discretion, will be void.

5. How to Enter

There are two (2) methods of entry. Ground Speed Warriors does not offer membership entries, and no membership purchase is required or available as an entry method.

A. Via Online Purchase. During the Sweepstakes Period, eligible entrants who purchase eligible digital posters or merchandise through Sponsor's online shop at shop.groundspeedwarriors.org will automatically receive five (5) Giveaway entries for every whole dollar spent. Entries are calculated based on the pre-tax amount of the eligible purchase, excluding shipping, handling, discounts, credits, refunds, returned items, and chargebacks.

For example, an eligible \$20.00 purchase of qualifying merchandise would receive one hundred (100) entries. Partial dollars and non-product charges do not generate entries.

Sponsor may void entries associated with cancelled, refunded, reversed, fraudulent, disputed, or returned purchases. Fraudulent activity, chargeback abuse, automated activity, or conduct inconsistent with the spirit of the Giveaway may result in disqualification.

B. Via Mail. During the Sweepstakes Period, eligible entrants may enter without purchase by legibly hand-printing the following information on a 3" x 5" card or paper: full name, complete mailing address, phone number, date of birth, and email address. Place the completed card or paper in a #10 business-sized envelope with proper postage affixed and mail it to:

Each valid Mail-In Entry must be postmarked by August 24, 2026 and received by September 11, 2026. Each valid Mail-In Entry will be worth one (1) Giveaway entry. Each envelope must be mailed individually.

Bulk shipments, mechanically reproduced entries, automated entries, photocopied entries, metered or grouped submissions, and entries submitted through any third-party entry service are prohibited. Mail-in entry cards and envelopes must be hand-printed by the entrant only.

No correspondence will be acknowledged. Requests for confirmation of receipt of mail-in entries will not be acknowledged. Sponsor is not responsible for lost, late, stolen, damaged, incomplete, illegible, misdirected, postage-due, undeliverable, or delayed mail-in entries.

6. Entry Conditions

To be valid, each entry must provide all requested information and comply with these Official Rules. Proof of purchase, proof of mailing, or proof of submission does not constitute proof of receipt by Sponsor. All entries become Sponsor's property and will not be returned.

Entries made by any person or entity other than the named entrant, entries originating from any other website or email address, and entries submitted through commercial sweepstakes subscription, notification, automation, or entry services will be declared invalid and disqualified.

By participating, entrants consent to Sponsor's collection, use, and disclosure of personal information for Giveaway administration, winner verification, prize fulfillment, legal compliance, fraud prevention, and any other purpose consistent with Sponsor's Privacy Policy, available at groundspeedwarriors.org/privacy-policy.

7. General Conditions

If the operation, security, fairness, integrity, or proper conduct of the Giveaway is impaired or incapable of running as planned, Sponsor may cancel, terminate, modify, or suspend the Giveaway in whole or in part.

Such causes may include tampering, unauthorized intervention, fraud, technical failures, human error, computer virus, bugs, natural disaster, public emergency, acts of war or terrorism, pandemic, platform outage, or any other cause beyond Sponsor's reasonable control.

If the Giveaway is cancelled, terminated, modified, or suspended, Sponsor may award the Grand Prize from among all non-suspect eligible entries received prior to the action taken, or in any other manner Sponsor determines to be fair and consistent with these Official Rules.

Sponsor may disqualify any individual who tampers with the entry process, the website, the online shop, the mail-in process, or any related system; violates these Official Rules; acts in a disruptive, abusive, fraudulent, or unlawful manner; or attempts to undermine the legitimate operation of the Giveaway.

8. Random Drawing and Winner Notification

One (1) potential Grand Prize Winner will be selected in a random drawing conducted by Sponsor or Sponsor's designee from among all eligible entries received during the Sweepstakes Period and all eligible Mail-In Entries timely postmarked and received.

The drawing will be conducted on or about Monday, September 14, 2026 at 12:00 p.m. CT. Odds of winning depend on the total number of eligible entries received.

The potential Grand Prize Winner will be contacted by Sponsor by phone, email, and/or USPS mail using the contact information provided at the time of entry.

If the potential winner cannot be contacted, fails to respond within the time specified by Sponsor, is found to be ineligible, does not comply with these Official Rules, fails to complete required documentation, declines the prize, or if prize notification is returned as undeliverable, the potential winner may be disqualified and an alternate potential winner may be selected.

9. Grand Prize

There will be one (1) Grand Prize available. The Grand Prize consists of one (1) custom 2025 Ford F-150 XLT 4x4 vehicle, plus tax, title, and license fees associated with the prize, as determined by Sponsor.

The vehicle is described on Sponsor's Giveaway page as a custom Ground Speed Warriors build. Prize details, specifications, appearance, features, equipment, and availability are subject to change in Sponsor's sole discretion.

Approximate Retail Value ("ARV"): [\$100,000]. The ARV represents Sponsor's good-faith estimate of the Grand Prize value. If the actual value is lower than the stated ARV at the time of award, the difference will not be awarded.

The Grand Prize will be awarded "AS IS" and without warranty by Sponsor of any kind, except for any manufacturer warranty that may apply. Sponsor has not made and is not responsible for any warranty, representation, or guarantee relating to the Grand Prize.

The Grand Prize may not meet emissions, safety, inspection, registration, insurance, titling, or operation requirements in all jurisdictions. The winner is responsible for determining whether the vehicle may be legally registered, insured, operated, and used in the winner's state and local jurisdiction.

Except for tax, title, and license fees expressly included as part of the Grand Prize, all other costs and expenses associated with prize acceptance, pickup, delivery, transportation, travel, insurance, maintenance, fuel, inspections, storage, optional equipment, modifications, and use of the Grand Prize are the winner's responsibility.

The Grand Prize may be picked up in Luverne, Minnesota, or at another predetermined location mutually agreed upon by Sponsor and the winner. Failure to take delivery as directed may result in forfeiture of the Grand Prize and selection of an alternate winner.

Released Parties are not responsible for late, lost, incomplete, illegible, inaccurate, stolen, misdirected, delayed, damaged, undelivered, postage-due, or garbled entries; technical errors; website errors; shopping cart errors; payment processing errors; printing errors; typographical errors; human error; unauthorized intervention; or computer, network, server, internet, email, mail, telephone, or delivery failures.

To the fullest extent permitted by law, Released Parties shall not be liable for indirect, incidental, consequential, special, punitive, exemplary, or multiplied damages, including lost profits, even if advised of the possibility of such damages.

For New Jersey residents and residents of any other jurisdiction where applicable law requires a different result, nothing in these Official Rules limits or excludes any rights, remedies, damages, or attorneys' fees that cannot be limited or excluded by law.

13. Disputes

Except where prohibited by law, all issues and questions concerning the construction, validity, interpretation, and enforceability of these Official Rules, or the rights and obligations of entrants and Sponsor in connection with the Giveaway, shall be governed by the laws of the State of Minnesota, without giving effect to conflict-of-law rules.

Except where prohibited by law, entrants agree that disputes, claims, and causes of action arising out of or connected with the Giveaway shall be resolved individually, without resort to any form of class action. Any judicial proceeding shall take place in a state or federal court located in Minnesota.

Claims, judgments, and awards shall be limited to actual out-of-pocket costs incurred, if any, including costs associated with entering the Giveaway. Entrants waive rights to seek punitive, incidental, consequential, special, exemplary, or multiplied damages, lost profits, injunctive relief, or attorneys' fees, except where prohibited by law.

14. Severability

The invalidity or unenforceability of any provision of these Official Rules will not affect the validity or enforceability of any other provision. If any provision is determined to be invalid or unenforceable, the remaining provisions will remain in effect and will be construed as if the invalid or unenforceable provision were not included.

15. Privacy

Personal information collected in connection with the Giveaway will be used to administer the Giveaway, verify eligibility, contact potential winners, fulfill the Grand Prize, prevent fraud, comply with legal obligations, and otherwise as described in Sponsor's Privacy Policy.
